

Dear Residents of District 5,


Happy New Year! We are excited to kick off 2025 and continue to make strides in our initiatives.

CRISIS RESPONSE

Although this month has brought excitement toward the new year, we must also recognize the difficulties we have faced. Unfortunately, our region experienced devastating fires, changing the lives of many. However, countless heroes stepped up. For instance, 28 fire engines and 180 brave firefighters from the Riverside County Fire Department.

Here in the county, we experienced Public Safety Power Shutoffs. Although this was done for safety, we understand the challenges this brought to our residents. To help residents, we opened food, hydration, and warm centers; collaborated with SCE to have Community Resource Centers available for additional support; and mobilized RUHS

Behavioral Health teams to provide care.

With your safety being our top priority, we actively monitored the situation, communicating updates to residents while preparing to address issues as they arise.

In addition, we partnered with the Riverside County Emergency Management Department to distribute ice to residents in Cabazon, who experienced power outages.

The PACT Act is a new law that expands VA health care and benefits for Veterans exposed to burn pits, Agent Orange, and other toxic substances.

The PACT Act adds to the list of health conditions that we assume (or "presume") are caused by exposure to these substances. This law helps us provide generations of Veterans—and their <u>survivors</u>—with the care and benefits they've earned and deserve.
